


# Keeper's Accomodation – Punta Stilo Lighthouse Monasterace (RC)









#### **TERRITORIAL FRAMEWORK**

Punta Stilo lighthouse is one of the most striking in Calabria, located on the promontory of the same name in the municipality of Monasterace (RC). The lighthouse was built in 1887 on ruins dating back to classical times, possibly belonging to a temple dedicated to Zeus. The Punta Stilo area is rich in archaeological evidence, including the park and museum of ancient Kaulonia, a Greek colony founded in the 7th century BC and destroyed by the Romans in the 3rd century BC.

#### ASSET


This is the farist's dwelling, decommissioned in the 1950s and handed over to the Agenzia del Demanio in 2009. It consists of a main building of approximately 170 square meters and an appurtenant area where there is an underground water tank of 23 square meters. The property is located at the entrance to the area where the Punta Stilo Lighthouse is located and is easily accessible from the SS106.



#### TERRITORIAL FRAMEWORK

The complex is located in the municipality of Vibo Valentia, in the heart of the city centre, at the foot of the Norman-Swabian Castle, now used as a museum. The historic centre of Vibo Valentia has undergone various redevelopment works over time, both by private individuals and by the municipal administration. Its presence in the city testifies to the ancient importance of the village, an influential colony of Magna Graecia.

#### ASSET

The complex is characterised by the presence of a twostorey building on the ground floor, and constitutes the former St. Augustine's Convent judicial prison. The building, of ancient construction dating back to the 1800s, is made of load-bearing stone masonry and is bordered by a boundary wall; these are spaced out from the building, constituting a safety cavity that can be crossed by a pedestrian pathway above.

# Former Railway Signalman's House no. 2

#### TERRITORIAL FRAMEWORK

The property is located within the town of San Cesareo, in a semi-central area, in an area characterised by lowdensity residential construction, with gardens and vegetable gardens. The property is only 900 metres from the municipal headquarters and 2.5 km from the San Cesareo motorway exit.

#### ASSET

Named "ex Casello 2 di San Cesareo", it is one of the many railway buildings belonging to the former S.T.E.FE.R. Rome-Fiuggi line. It consists of a two-storey above-ground building with a rectangular floor plan, made of load-bearing masonry, with pitched roofing and a roof covering of tiles and roofing tiles. The building measures approximately 8.00 x 5.00 meters and has an external appurtenant area with a regular quadrangular shape and level ground. Originally intended as a railway tollhouse, it is now disused and unused.





# Former Convent Saint Bonaventura previously Remand Prison Caltagirone (CT)





#### TERRITORIAL FRAMEWORK

The property, called Ex Convento di S. Bonaventura, is located in the central area of the municipality of Caltagirone, 300 metres from the famous steps of Santa Maria del Monte. The complex is located within the most touristic area of the city of Caltagirone, a city that has been awarded the title of World Heritage Site by UNESCO with the designation of "The Late Baroque Cities of the Val di Noto" (south-eastern Sicily) and is attractive to tourists.

#### ASSET

It is two storeys above ground, with an additional floor added in the south-west area only. The building is square in shape with a central courtyard and perimeter wall, also of the same shape.Specifically, the property has a net floor area of approximately 1,019 square metres on the ground floor and a net floor area of approximately 1,061 square metres on the first floor.



# Former Air Raid Shelter Perugia (PG)





Riottosa is located in the hilly area south of the municipality of Florence, in the hamlet of Galluzzo and at the foot of the hillock of Montacuto, where the Florence Charterhouse stands. The area, located on the border between the municipalities of Florence, Scandicci, Bagno a Ripoli and Impruneta, is one of the richest and oldest in the municipal territory, a crossroads of three important and historical road axes: Via Cassia, Via Senese and Via Volterrana.

#### ASSET

The building was constructed by the Postal and Telecommunications Administration in 1949 and used until the beginning of the 1970s as a sorting centre for telegraph traffic by the PP.TT Administration. The building has two above-ground floors, plus a basement and is accompanied by a large piece of agricultural land of direct relevance.
