STATE-OWNED PROPERTIES: CALLS FOR TENDERS PUBLISHED FOR THE VALORISATION IN CONCESSION OF 20 PROPERTIES IN VARIOUS REGIONS

Agenzia del Demanio is calling on entrepreneurs and third sector organisations for the recovery and reuse of barracks, convents, hangars and churches. Nine buildings are available for temporary use.

Rome, 11 July 2025 – The Agenzia del Demanio has published the first tranche of calls for tenders for the concession of state properties aimed at private investors, third sector entities, and operators in the social, tourism, and cultural sectors. It consists of a portfolio of 20 properties located in various regions of Italy proposed to the market with different concession tools: temporary use, concession for valorisation, and facilitated concession.

The tenders, which are published on the website www.agenziademanio.it in the section denominated Gare e Aste (Tenders and Auctions) and in the in the In Evidenza section, include: 9 buildings in temporary use, 8 buildings in valorisation concession and 3 buildings in concession to third sector organisations.

In particular, the buildings and areas proposed for **temporary use**, for a period ranging from 6 months to 6 years, can be opened to the public for civic, social and cultural initiatives and activities, pending the completion of the redevelopment work.

The deadline for submission of the offer is **25 September 2025**, **12 noon** and concerns the following assets:

For assets proposed for **redevelopment concessions** from 6 to 50 years for investments aimed at their regeneration, the deadline for submission of the offer is **11 December 2025**, **12 noon** and concerns the following assets:
